2. Approval of Minutes for the business meeting of EGSG during the 2007 San Francisco AAG meeting. James Smith (Towson University)

**Addendum: Joy Adams elected to Board. Approved by acclamation.**

Lawrence Estaville-on point of order, seconded by John Frazier, put forward motion to formulate new bylaws.

Wei-copy was not found, so problem is acknowledged. Dave Kaplan-proposed discussion on committee. LE-opportunity to bring bylaws to present, and place on website. Proposed subcommittee of 3-5 members. Jim Allen-on need for formal bylaws; LE-bylaws in accord with AAG practice. JF-propose to close debate. Motion for committee passed.

3. EGSG has 28 sponsored sessions for the 2008 AAG meetings. This compares with 29 in 2007, 18 in 2006, and 15 in 2005.

John-encouraged all to attend and join EGSG; participate AND Join;

4. Membership report – John Frazier: EGSG has 181 members as of 4/11/08, of which 110 are regular members and 71 are student members; compared to 187 members last year (114 regular and 73 students). EGSG has 21 international members, including 1 each from Germany, Japan, Switzerland, and Turkey; 2 from Australia, 3 from UK, and 12 from Canada.

5. Treasurer's Report – Jim Smith: the balance in EGSG's bank account was \$ 531.

JMS-report based on decreased revenues for Miami conference; our normal amount is about \$1,000 at AAG, but \$500 for REP was necessary for co-sponsorship.

Lawrence Estaville-made a commitment to replace \$500 for Race, Ethnicity and Place money.

11. Report on Specialty Group chair meeting – Wei Li

Platform for new president, John Agnew: integrating the various subdisciplines within Geography (Physical, Human etc.); Discussion of registration fee and child care issues; fees will not be reduced due to increasing costs and sliding scale for different memberships will be retained; AAG manages SGs finances; email listings, insure that current email address is submitted with annual membership; more than 7000 registered for Boston meeting; AAG has created an AAG Developing Regions Program-\$20 membership for those from eligible countries; Journals-we can request electronic only

Lawrence Estaville-EGSG has traditional ties to CGSG; new, Business Geography SG; encouraged to collaborate with this group, especially for those who research ethnic business;

12. **Election of a new Secretary/Treasurer:** the term expires for one member, Wei Li (reelected since 1996).

Lawrence nominates Eugene Tetty-Fio, he declines; LE noted importance of having African-American Board member; John Frazier nominates Ian Yeboah, who is currently not present, who is willing to stand as new Board member. LE nominates Heather who respectfully declines at the present time; Carlos Texeira nominates Stavros Constantinu, who was acclaimed by voice.

Lawrence Estaville proposed to honor Jim Allen, who has now retire from CSUN; Jim Allen was the second Chair of the group; Jim Allen: expressed pleasure at the creation of the group by Lawrence Estaville; he emphasized the importance of the group to scholarship and intellectual endeavor; he emphasized the importance of the mutually-supportive nature of the EGSG community.
